Tony D: This motion has been turned down 2 or 3 times. We are supposed to have this. If you look at the old schedules, a lot of those meetings have folded. No addict seeking recovery should die. There are meetings in our area right now that desperately need help. We thrust newcomers into service without showing them what service work is all about. I have consulted many old timers regarding this matter.

Betty: I remember vividly that we don't have enough willing servants to fill the vacant subcommittee positions that we have now, why should we create more ?

Kris R: I know that I suffer from fear and confusion, service work helps me get out of that and to gain some serenity. Outreach is service work that would benefit the area, just like individual service work benefits the individual addict. If there is willingness for this, I think this area as a whole would benefit from working on something together.

Chris W: In reading the motion, does it say we would create a subcommittee in the area ? I've lived in the outlying areas, and there are a lot of newcomers and people who identify themselves as "and a (alcoholic)". I think this motion would bring a lot more unity to the area. We need to be able to communicate with all of our meetings.
