**Treasurer – David E.:**

Our current balance is \$3,450.00, leaving us \$300.00 over our prudent reserve. We will be making a contribution to the Volunteer Region for the amount of \$482.89.

It has come to my attention over the previous months that this area may benefit from the use of a debit card. There are a few expenses that this area has on a regular basis which people in our fellowship pay for, expecting to get reimbursed. We can pay for these expenses ahead of time or on time with the use of a money order or debit card. This would prevent the GSMANA from having to reimburse individuals that “cover” its own expenses. The best examples for this are the bill for the meeting schedules and the bill for the phone line. As of now we, as an area, wait for individuals to pay these bills, and then we pay them back. I would like to mention that this would not be used for miscellaneous expenses, but only for the regularly recurring bills. To clarify, the intention is not to have a debit card that gets passed around and “swiped” at anyone’s convenience. It is for the regularly reoccurring bills that can be paid over the internet or by having an account based on this card.

There is the concern that this debit card could be misused. If it falls in the wrong hands, someone may misappropriate our area’s funds more easily. There is also the opportunity that someone has a better idea than I do. This happens often. I am open to suggestions and questions regarding this issue.

The H&I subcommittee had another productive meeting prior to today's ASC meeting. All panel leaders were present except for one, who sent his report through another panel leader. We continue to carry meetings into center point (inpatient and detox), Peninsula's Adolescent wing, Peninsula's Adult detox (two meetings a week), Gateway Home for adolescent boys, the Knox county detention facility, men's and woman's meetings at Anderson County Detention facility and a women's meeting to the Sevier county jail. Support for the meeting at the Knox county jail is on the upswing, with more applications being approved; many thanks to Greg V. and David E. for their perseverance. Other correctional facility meetings at Anderson county and Sevier county are struggling with bureaucratic red tape; however, the panel leaders at those facilities continue to carry the message as best they can. Emilee S. brought to the subcommittee the willingness to help the subcommittee explore the possibility of carrying a monthly H&I meeting into Brushy Mountain Prison. Please help V.S. spread the word –all those interested in getting involved in this process should meet here at Square Dance Inc. at 12:30 p.m. April 22, 30 minutes prior to the start of next month's subcommittee meeting, to discuss it. Literature expenditure for this month was \$389.87, plus \$10 for rent, putting our total expenditure at \$399.87, 13 cents under budget.
