Mr. Chair, per concept #10, in 12 Concepts of Service, I would like to file a grievance, pertaining to the motion to remove the WOLF group meeting from the schedule.

1. I felt this motion was out of order because:
Public Information made this motion and per our By-Laws; *page 5, 2B*, only those listed below can make, second, or amend motions: Area Subcommittee chairs, *But only as it pertains to that subcommittee business.*
2. Public Information is for external guidance not internal.
3. By laws; *page 10, line 2*, states: The GSMASC PI Subcommittee deals with how NA interfaces with society, (telephone, media), NA image and how we can get those outside of the fellowship to carry our message to addicts we can not reach. This committee deals with matters through the media, (e.g. instigating Public Information campaigns, etc.)
4. By-Laws *page 11*; NA groups are unorganized in the sense that there is no authority within them. No individual runs any group or otherwise governs anything. Our groups adhere to the Spiritual Principles of the Traditions for their "authority". The service boards and committees we create make it possible for us to be a unified fellowship. However, even they are not an organization in the sense of being an authority or having power. Our experience has shown that addicts don't take orders well, especially from someone viewed as an "authority". These boards and committees simply make *suggestions* and act in ways that are directly responsible to aid in carrying the message to the addict who suffers.
5. Our website for this area even says, The PI/Phoneline subcommittee deals with how NA interfaces with society and how we can utilize services outside of NA, including the media, to carry our message to addicts we cannot otherwise reach. Rather than being promotional, th goal of our PI campaigns is to attract suffering addicts to our meetings and let them know there is hope for a better way of life.
